One of our Directors has resigned from the Board and created a vacancy we would like to fill in August 2026. APPLICANTS MUST LIVE IN THE DISTRICT (WHICH INCLUDES FAIRVIEW AND FIVE CANYONS) AND BE A REGISTERED VOTER. This vacancy will be filled by appointment of the Board for a duration of approximately 3 months. This appointment is for a term that expires December 3, 2026. An election will be held in November 2026 to fill this seat for the 2027-31 term.

The District holds six Regular Monday evening meetings each year along with Special meetings that are scheduled when needed. Directors make policy decisions for the District and receive a per-meeting stipend as permitted under applicable law and District policy.
